

CAT 2026 Test Series

- The 30 Mock CATs for CAT 2026 (except CDC Launchpad) will be divided into two types:

1) CDC PRO mocks

- CDC PRO mocks will be open for Only 3 Days – Saturday, Sunday and Monday as per the schedule.
- CDC PRO mocks will be conducted in 3 slots each day. The 3 slots are – 8:30 am to 10: 30 am, 12:30 pm to 2:30 pm, 4:30 pm to 6:30 pm.
- Once the test window closes, the test will reopen on the reopen date mentioned in the schedule and you can attempt the test as per your convenience.
- Live Analysis for CDC PRO mocks will be available at 8:00 pm on the analysis date mentioned in the schedule.

2) CDC FLEXI mocks

- CDC FLEXI mocks once opened can be attempted at any time as per your convenience. The tests will be made available at 10:00 am on the test date.
- Recorded Analysis of the CDC FLEXI mocks will be made available at 8:00 pm on the analysis date mentioned in the schedule.

Note: All the CDC PRO mocks and CDC FLEXI mocks before CAT 2026 Notification will follow the pattern of CAT 2025. Any changes in the pattern will be implemented in the mocks that are scheduled after the CAT 2026 Notification.

Note: CDC Launchpad is the first mock and is exactly like CDC FLEXI (available for attempt anytime but with Live Analysis)

Note: OPEN CDCs are CDC PRO 2, 4, 8, and 15. The OPEN CDCs can be attempted at Test Center (at a nominal additional charge) to experience CAT before CAT.
